- Hounds will go out on Wednesdays and Saturdays, plus specified holidays during the season, Mondays and additional hunt days at the discretion of our Masters of Foxhounds.
- New Members may join the Hunt at any time during the 2022-2023 season at the Early Payment Price.
- All Riding Memberships are subject to the approval of the Metamora Hunt Board of Directors.
- All Riding Memberships: included in the dues paid, will be made subscribing members of the Masters of Foxhounds Assoc. and will receive the Covertside Magazine as a result.
- All Riding Members, including Junior Members, are required, as a condition of membership, to procure a minimum of two ads for the Annual Metamora Hunt Country Magazine or an equivalent amount of class sponsorship in the Hunt Dressage Show.
- All Riding Members are also required to lend their fair share of time and talent volunteering to support the non-hunting events and activities of the Hunt throughout the year. This effort is very important to the success and perpetuity of the Hunt and good faith with our Landowners. Please complete the enclosed Member Participation Form and mail it with this application.
- Should you wish not to become a Riding Member at this time, you may "Cap" (Guest Hunt) on a per diem basis. All Cappers must adhere to the process of contacting the Master of Foxhounds well in advance of the day they wish to hunt. Adult Capping fees are \$55 on weekdays and Saturdays, and \$100 for Opening Day of the formal hunt season and Thanksgiving Day. Junior Capping fee is \$25 on all days. Non-subscribers are limited to three caps during the 2022-2023 season. All capping fees are due at the beginning of each Hunt Meet.
- Landowners may cap at no charge up to a total of <u>three times</u> per family (immediate family only) for the season (landowner caps are non-transferable).
- A Landowner is defined as "The principal titleholder to property regularly hunted by the Metamora Hunt."
